Dear sir or madam,

Thank you for your inquiry about observing the European Union (EU) Regulation No. 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH). First of all, we would like to inform you that due to the great number of various different inquiries about REACH, an individual answer to each letter cannot be given due to time and cost involved. So we may comment as follows:

FRIWO Gerätebau GmbH is only concerned as a downstream user by the REACH regulation. The duty to pre-register or register because of manufacturing and bringing into the market of substances and chemicals do not apply to us.

The goods we supply you with are defined as products and not as substances and/or preparations (acc. to article 3 of the term definition). No substances are released by our products, so article 7 of the regulations is also not applicable to us.

As a downstream user, we will comply with all the requirements imposed on us by the REACH Regulation. According to Art. 33 REACH, our suppliers are obliged to notify all so-called "Substances of Very High Concern" (SVHC) from the candidate list of the European Chemicals Agency (ECHA) and the restricted chemicals and substances from Annex XVII of the REACH Regulation ((EU) 2021/1297).
